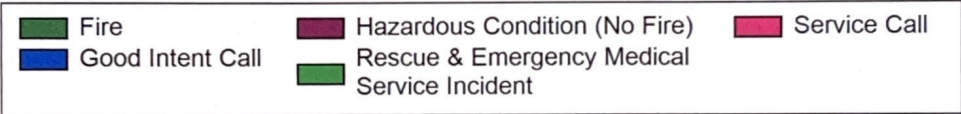
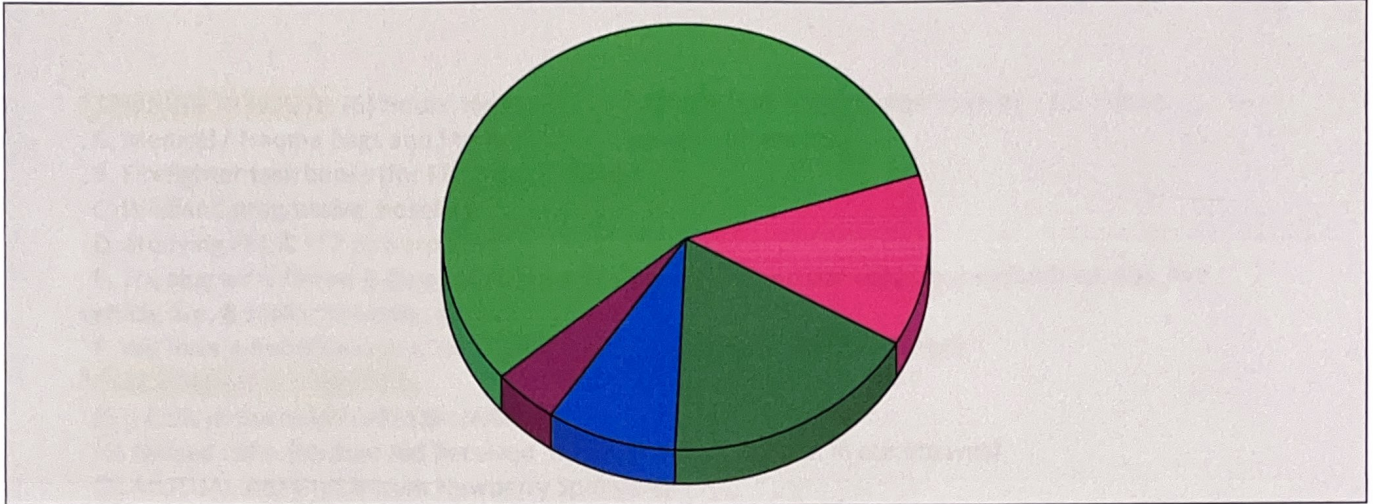

***EVENTS/ACTIVITIES/GRANTS:**

- A. Update on Clearways donation to NSFD for the \$76,000. New field Supervisor! The last supervisor took our request to the higher ups, & came back to us that after new fiscal budget comes in effect July 2025, they will support our request for Structure gear. Now with their new supervisor he will not promise/honor NSFD request for the \$76,000 for gear.
- B. Wildland gear- paperwork was sent in for 20 sets of "wildland jackets, duel compliance navy blue pants, wildland boots" approx..\$18,000. Unknown of when we'll be retrieving gear.
- C. FF Mini Academy- every weekends March thru April 2025. NSFD had to purchase the FF1/FF2 books, hotel room for the Saturday night stay over's, and the certification fee's.

***PUBLIC COMMENTS/REQUEST:**

CERT- SB County representatives have asked when we want the classes, & my response every time is "the sooner the better" Apparently, he's looking into May 2025. I have a calendar of CERT trainings in different communities.

3/19/25-UPDATE- SBCounty, office of emergency R. Gonzales has not found Newberry Springs an instructor to teach our CERT class for this year. Gonzales is asking me to take the "Train-the-Trainer" CERT class in May 20-22 in Rancho Cucamonga. He has a seat reserved for me if I choose to be an instructor.
